FINAL ORDER AND JUDGMENT

Following entry by this Court of an Interlocutory Order of Default Judgment against Defendants Acres Home Heart & Vascular Institute Associates, Global Cardiovascular Associates, and Conrad R. Murray on November 6, 2007, this cause comes before the Court pursuant to Missouri Rule of Civil Procedure 74.05(a) to assess damages. Plaintiff appears by counsel and through its representative via Affidavit. Defendants Acres Home Heart & Vascular Institute Associates, Global Cardiovascular Associates, and Conrad R. Murray fail to appear, plead or otherwise defend as provided by the Missouri Rules of Civil Procedure and, therefore, are in default.

This cause now being submitted to the Court upon the pleadings, exhibits, testimony and evidence adduced, and the Court, being fully advised in the premises, finds that Plaintiff is entitled to a Default Judgment against Defendants Acres Home Heart & Vascular Institute Associates, Global Cardiovascular Associates, and Conrad R. Murray, jointly and severally.

WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED,
that judgment is hereby entered in favor of Plaintiff and against Defendants Acres Home
Heart & Vascular Institute Associates, Global Cardiovascular Associates, and Conrad R.
Murray, jointly and severally, in the principal sum of \$128,787.94, plus prejudgment
interest from July 12, 2007 through November 12, 2007, in the amount of \$3,905.98, plus
Plaintiff's reasonable attorneys' fees ~~and costs~~ in the amount of ~~\$3,221.54~~, for an
aggregate sum of ~~\$135,915.46~~ ^{\$135,302.42} *plus the costs the court.*

Interest shall accrue on the judgment at the rate of 9% per annum and continue
thereon until the date of satisfaction.

FURTHER, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that
Plaintiff, under Count II of its Petition, has the right to immediate and exclusive
possession of the Equipment as described in Exhibit ~~2~~³ to Plaintiff's Petition, and that
Defendants Acres Home Heart & Vascular Institute Associates, Global Cardiovascular
Associates, and Conrad R. Murray shall deliver the Equipment to the Sheriff of Harris
County, Texas or to the Sheriff of Clark County, Nevada.

Costs taxed to Defendants Acres Home Heart & Vascular Institute Associates,
Global Cardiovascular Associates, and Conrad R. Murray.






