While I understand you have checked up on the credentials and authenticity of Dr. Tohme through personal sources, I nonetheless have reservations about whether or not he is the real McCoy. When I checked a couple on-line search engines for Dr. "Tohme" to see if I could find reference to him, the only thing I found were a few recent quotes from Dr. Tohme as Michael Jackson's "publicist" and some references to him in various blogs by people who referred to him as a mystery man who claims to represent Jackson. I found nothing else on him -- almost like he never existed until he met Michael Jackson. It's possible there are references to him on the Internet in Arabic, rather than English (which I didn't check because I don't read Arabic). Nonetheless, I recommend that a background check be performed through a private investigator and/or at a minimum, that someone at AEG Live meet with Michael Jackson to make sure he understands that we are entering into a tour agreement with him that will require him to perform a worldwide tour
